Call to Order Pat Bird opened the meeting at 4:00 PM.

Treaty Land Acknowledgement

Pat Bird read the following Treaty Land Acknowledgement for Prairie to Pine Regional Council, developed by the Equity & Diversity Committee:

"Creator. Eternal Spirit. God of all. We gather tonight on your land. We gather on land some called Turtle Island and others call Canada. We acknowledge that the lands of the Prairie to Pine people are covered by Treaties 1, 2, 3, 4, 5, and 9. The Prairie to Pine office is located on Treaty 1 land. These are the traditional lands of many Indigenous peoples, including Anishinaabe, Ojibway, Cree, Oji- Cree, Saulteaux, Dakota, Swampy Cree, Muskegoik, Dene, and the Metis nation. We acknowledge that as settler people, we have not lived up to the promises of the Treaties with respect to the people or the land. We wish to do better, and particularly in the Prairie to Pine region, we aim to be part of the reconciliation efforts."

* A revised land acknowledgement statement is currently being drafted. The above land acknowledgement statement will be updated to reflect the new one when it becomes available.

Guiding Principles Diane Dwarka reminded us of the guiding principles we follow during our meetings.

Opening Worship Joey Dearborn led us in worship and read a story called 'The Leaky Bucket.'

Check-In We checked in by sharing what things might lead us to have holes in our own buckets,

and despite any holes, what are the things that give us hope.

Agenda We reviewed the agenda.

022 – 2021/2022 It was agreed by consensus:

That Prairie to Pine Regional Council Executive approve the agenda as distributed.

Approval of Minutes We will review the minutes of October 7, 2021 when they are received.

BUSINESS ARISING A lot of work is in progress, and we will hear more as we go through the meeting.

REPORTS

Correspondence

Finance Valerie Beckingham reported.

A financial report ending September 30, 2021 (Appendix A) was provided for information.

We reviewed the 2022 Draft Budget (Appendix B).

Since the pandemic began in 2020 and changed the way we work, as well as 2019 being a transition year, we still have not had a normal budgeting year.

In the governance budget, grant amounts match what we projected and budgeted. Other income in governance is mostly interest. Office rent figures still need to be finalized.

If the annual meeting is moving to an in-person meeting every three years, we think it would be a good idea to budget for the annual meeting on a year-by-year basis.

Heather Dootoff noted the amortization amount should be removed.

Valerie Beckingham will send out an amended draft that eliminates the amortization amount of \$20,780 for the 2022 Budget.

023 – 2021/2022 It was agreed by consensus:

That Prairie to Pine Regional Council Executive accepts the *Prairie to Pine Regional Council 2022 Draft Budget (Appendix B)*, as presented.

Co-chairs Pat Bird reported.

Pat represented Prairie to Pine Regional Council at the Commissioning of Sam Ross as a Designated Lay Minister which was held in Cross Lake, Manitoba on October 17th. It was a long wait for Sam to receive his recognition and certificate.

Pat and Diane Dwarka attended a General Council 43 meeting and received reports on the Anti-Racism Action Plan and the United Property Resource Corporation. There has been a push to consider our land acknowledgments so they may lead us into a deeper understanding of the people we live with.

Prairie to Pine Structure document

The task group met on October 18, 2021 and continued the 'Who We Are' portion of the structure document. Committee reports will be incorporated into the document as they are received.

The next task group meeting will be November, a date to be determined.

Executive Minister's Report

Shannon McCarthy reported.

New office space

The Prairie to Pine Regional Council office will be downsizing and relocating to the Centre for Christian Studies (CCS). We have begun the process of packing and sorting through supplies and furniture that have accumulated over the past years. We are renting three offices in the basement and are assessing what we need to take, what we have space for, and if we need additional storage.

The office relocation came out of staff working at home during the COVID-19 pandemic. It was decided that we could continue to effectively work as a team and stay connected digitally. Downsizing the office will result in overall savings in rent and costs.

General Council work

The General Council has been holding learning sessions every Tuesday evening on various topics, some of which have been:

- Israel / Palestine
- Love and Justice Conference

Fred Douglas Foundation dissolution

We are in the process of working to dissolve Fred Douglas Society as an incorporated body in the United Church of Canada.

Prairie to Pine can still name two people to their board.

At the October meeting, Grant Queskekapow shared some stories about his experience with residential schools. After further conversation with Julie Graham,

Grant would like to move forward on creating talking and listening circles in Norway House for survivors of residential schools.

We had a discussion on who might bear witness to these stories and agreed this proposal needs further conversation.

Annual Meeting Planning

Shannon called a meeting with the chairpersons of all three regional councils to discuss common issues. One topic they discussed was the balance of virtual and inperson meetings across the three regional councils.

It was agreed that we would begin a three-year cycle of two virtual meetings and one in-person meeting a year, with the in-person meeting rotating between the three regional councils (Living Skies and Northern Spirit).

Diane Dwarka and Pat Bird will suggest a date for the 2022 regional meeting.

The Nominating Committee will be waiting to hear on the date for the 2022 Regional Meeting.

Another thing to consider as we decide on a date and assemble a planning committee is any nominations for Moderator that may arise from this regional council.

Grants Committee

Pat reported submitted a report on *Mission and Support Grant Applications for 2022* (Appendix F).

Four Outreach Ministries have submitted grant applications for the 2022 funding year, we have a budget of \$126,000 to administer, and that total grant requests were \$150,500, the Grants Committee has the following grant recommendations:

Land Acknowledgement

We were joined by Jan Van Aertselaer for our land acknowledgement discussion.

We reviewed the proposed Land Acknowledgement statement for Prairie to Pine Regional Council.

The process in writing the draft land acknowledgement included:

- Including the English and Indigenous spelling of Indigenous communities.
- Including language to acknowledge settler people are part of the colonization of Canada.

We discussed the proposed land acknowledgement statement. There were many concerns about the language used, some of which were:

- The use of the word 'we' which suggests a group of people extending to another, yet who does 'we' include?
- The use of the word 'settler' to describe the entirety of the regional council, yet not everyone within the regional council can be described as 'settler.'
- The importance in using the word 'truth' along with reconciliation.
- If this statement is to be used by anyone within the regional council, the language speaks from the perspective of settler people, and could not be used by newcomers or Indigenous communities.

We thanked M Chorney, Diane Dwarka, and Stewart Hill for tackling the re-writing of the land acknowledgment. Another draft will be submitted in December 2021.
