BURSARY FUND COMMITTEE PROCEDURES:

1. Each applicant will be treated individually.
2. The amounts distributed will be determined by:
 - the available funds
 - the nature of the request
 - the total number of requests
3. Available monies to be allocated by consensus of the Prairie to Pine Regional Council Bursary Fund Committee.
4. Normally, the amount of money available for disbursement is determined by the amount on hand.
5. No awards will be granted for post-graduate theological studies or continuing education programs.
6. ***The Prairie to Pine Regional Council Bursary Fund will be available only to candidates for the Order of Ministry and applicants in the Designated Lay Minister program from the Prairie to Pine Region and must be registered in theological studies.***
7. First and second time applicants will be given preference.
8. Applicants will be advised by letter of the Committee's decision.

APPLICANT PROCEDURES:

Applicants may obtain an application form from the Prairie to Pine Regional Council Office or our Prairie to Pine Regional Council website or Weekly News.

Completed forms should be returned to Darlynn Smith of the Prairie to Pine Regional Council Bursary Committee by **MAY 31st**. Under special circumstances, late applications may possibly be considered.
