#### 2022-15

Whereas in a meeting held at Birtle, Manitoba. September 29, 2004, the Assiniboine Presbytery passed motion #21 authorizing the closure of Medora United Church and that the trustees remain in place until the disposition of assets, and motion #22, authorizing the disposition of assets and the demolition of the church building, but did not authorize the sale of the land.

Whereas on July 13, 2015, the trustees of Medora United Church requested the RM of Brenda Waskada to accept as gift from the former Medora United Church certain real property described as Lots 6-10, Block 5, Plan 24, in the community of Medora, in the Rural Municipality of Brenda.-Waskada, the vacant site of the former Medora United Church.

Whereas on September 9, 2015, the Rural Municipality of Brenda-Waskada passed resolution 122, accepting the gift of land Lots 6-10, Block 5, Plan 24 in the RM of Brenda-Waskada from the trustees of Medora United Church.

Moved by Keith, seconded by Wayne, that by that the Prairie to Pine Regional Property Commission approve the transfer of the above described vacant lot at the site the former Medora United Church as gift to the Rural Municipality of Brenda-Waskada. Carried.

### 2022-16

Whereas the following resolution was duly passed by Assiniboine Presbytery at a meeting of the said presbytery held at Birtle, Manitoba, on the 29th day of September, 2004;

Moved by Dwight Rutherford, seconded by John Oldenkamp, that Assiniboine Presbytery approves the request of the trustees of the former Napinka United Church to transfer the building, real property and contents of the former Napinka United Church, located in Napinka, Manitoba, and legally described as Lot 8, Block 12, Plan 16, RM of Brenda (CT#D534) to the Rural Municipality of Brenda. Carried. Whereas this transfer was never completed,

Moved by Wayne, seconded by Keith, that by that the Prairie to Pine Regional Property Commission approve the transfer of the above described vacant lot of the former Napinka United Church the Rural Municipality of Brenda-Waskada.
