### Report to Executive from Committee on Community of Faith Support

March 3, 2022

The Committee on Community of Faith Support appreciates the sharing of minutes or highlights from meetings among the Committees on Ministry Personnel Support, Lay Ministry /Lay Leaders' Support and the Pastoral Relations Commission. This helps to keep us informed and allows us to collaborate on some of our work. We also appreciate the good working relationship we have with the Property Commission when both groups are involved with the same Community of Faith.

We are preparing to recognize & celebrate what we think will be the final group of 15-20 completed covenants of mutual commitment, accountability and support between communities of faith and the regional council. We are anticipating this will happen as part of a worship service at the May meeting of the Regional Council.

CCFS members have also been or will soon be involved with six communities of faith on the way to being disbanded. Central (Brandon), Brandon Hills, Rossendale, Kildonan, Alexander, Miniota

We have been or continue to be engaged with another four as they consider some form of structural transition – Stratton-Rainy River, Pembina Parish, Elm Creek, Altona.

Some of our work involves reviewing changes to community of faith governance structures and requires much back and forth conversation, often by email, and a lot of reference to "what the Manual says," and "how do we describe what we do."

Looking ahead, we aim to have Self-Assessment resources ready to send to the first group of 45 Communities of Faith by late fall, with the goal of receiving the first self-assessment reports just over a year from now. The Committee on Community of Faith Support understands the self-assessment as an opportunity for each CoF to reflect on how they are doing relative to their mission / vision / goals. We are excited to think about how we might bring two or several communities of faith together for some part of the self-process.

Our committee also initiated and look forward to being part of an online gathering for pastoral charge supervisors, to hear issues or concerns they have and to explore how we might offer support. Judy has agreed to set this up.
