

**Prairie to Pine Regional Council**  
**Ministry Personnel**  
**July 1, 2024 – June 30, 2025**

Prairie to Pine Regional Council is blessed by many ministry personnel who are retired or unassigned and are willing to offer their skills as visiting ministry personnel. These ministry personnel are in formal association with a community of faith and have all their required credentials up to date. All those listed are able to celebrate the sacraments unless otherwise specified.

From time to time, ministry personnel may be invited to provide worship leadership and preaching, pastoral care and visitation, and/or other services to a community of faith when the incumbent ministry personnel is on vacation, study leave, or other short-term leave. These services are intended to cover only one or two Sundays or weekends at a time. An ongoing need for these services must be discussed with the regional council to determine whether an appointment should be made.

**The minimum daily rate is \$231 (2023) and \$247 (2024).** This covers a full working day, or any portion thereof, and is not linked to any specific number of hours served. The rate is based on the cost of living group 1, increment category F minimum salary. **The parties may negotiate a higher daily amount but cannot negotiate a lower amount.** In addition, the community of faith must reimburse the visiting ministry personnel for travel and incidental expenses (i.e., meal allowance and accommodations, as necessary).

**Note:** The Canada Revenue Agency requires that a T4A be completed for annual aggregate amounts over \$500 paid to an individual. ADP will produce a T4A on request (the amount will show in box 48, Fees for Services).

The information is organized geographically from east to west in terms of where the ministry personnel are located. It includes churches where their formal association is held, email, phone contact and general area where they are willing to offer services.
