Motion 2024 - 36

Moved by Wayne, seconded by Ken, that the Property Commission of the Prairie to Pine Regional Council gives its consent to the trustees of Vermilion Bay United Church, Vermilion Bay, Ontario, to list or seek to sell certain real property, the legal description of which is ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Township of Langton in the District of Kenora, being composed of part of lot 3, bloc 3, plan M238 and which may be more particularly describes as follows:-

PREMISING that the east limit of lot 3, block 3, plan M238 has an assumed astronomical course of north 2 degrees 34 minutes west and relating all bearing herein thereto; COMMENCING where a survey post has been planted at the north east angle of lot 3, block 3, plan M238;

THENCE north 86 degrees 16 minutes west 130.8 feet along the north limit of the said lot 3, to where a survey post has been planted;

THENCE south 2 degrees 34 minutes east 106.6 feet along the west limit of said lot 3 to where a survey post has been planted;

THENCE north 87 degrees 26 minutes east 130 feet parallel to the south limit of the said lot 3 to where a survey post has been planted;

THENCE north 2 degrees 34 minutes west along the east limit of said lot 3, 92.5 to the point of commencement.
